

## **Call for participants**

For the training course "United in Peace" 8 – 17 September 2021 Vadul lui Voda, Rep. Moldova

Together with our partners, we are looking for participants from Azerbaijan, Bulgaria, Cyprus, Denmark, Moldova, Armenia, Turkey, North Macedonia, and Ukraine.

### Summary:

The Activity is an eight-working day Training Course for 30 youth workers which will take place between 8<sup>th</sup> and 17<sup>th</sup> of September 2021, 8<sup>th</sup> being the arrival day, while the 17<sup>th</sup> - the departure day.

The aim of 'United in Peace' is to promote peace and ease the effect of conflicts on young people, by increasing youth workers competences in supporting young people's personal development, who live in conflict or post-conflict regions.

The European Union's main objective is to promote peace, follow the EU's values and improve the wellbeing of nations, and it is expected that 'United in Peace' will contribute to a more peaceful Europe.

The training course is non-academic, and it is based on non-formal education. The methods applied by the facilitators are mainly, but not exclusively, interactive.

The Training course will support the development of your skills, knowledge and attitudes in reference to:

- Different types of conflict
- Human rights, and the connection between human rights and conflict.
- Different approaches to deal with conflict including, prevention, resolution, management, transformation, and tools for intervention such as conflict-mapping, cooperation solutions, negotiation and mediation.
- Developing bespoke youth work methods to support young people in post conflict regions
- New inspiration and youth work practices from the partner countries

The activities will be conducted in English and translation will not be provided. Therefore, the participants are expected to have a good level of English, both written and spoken.

Participation in the training course is free of charge.





### Participant's profile

The target group of the seminar is **youth workers actively involved in the partner organisations.** Participants must as well fulfil the additional criteria below:

- Be over 18 years old;
- Have direct responsibility for working with young people in the partners' organization;
- Work in a conflict or post-conflict region, or potential to work in the near future;
- Have a good command of English;
- Be able to attend the entire training course;
- Have potential and be motivated to disseminate the results of the project.

Candidates who do not fulfil the requirements will not be accepted.

#### Application and selection procedure:

The deadline for applications is **August 11**<sup>th</sup>. The results of participants selection will be announced by the organizer on **August 13**<sup>st</sup>.

Within 5 days after the selection results are announced, participants must prove that they have purchased their tickets with a copy of the invoice and a copy of the e-ticket.

#### Travel:

The travel budget per participant for this project is as follows:

Country	Distance Band	Budget*
Moldova	10 – 99 km	20€
Ukraine, Moldova	100 – 499 km	180€
Denmark, Bulgaria, Azerbaijan, Cyprus, Armenia, Turkey, North Macedonia	500 – 1999 km	275€

\*calculated with the <u>distance calculator</u> of the European Commission

Participants will be reimbursed for their travel expenses up to the amount available for their country and no more than the real costs. The travel budget cannot be increased if the participant travel on a bigger distance band than above.

The amounts have been calculated using the distance calculator of the European Commission from the location of each sending organization to the venue.

Should the travel expenses exceed the contribution available, participants shall cover the extra costs from own resources.





#### **Reimbursement of travel expenses**

The reimbursement of travel expenses will be done after the activity. To get reimbursed, participants will send by post their travel documentation in original. The reimbursements will be made by bank transfers within 45 days after the organizer have received the original documentation by post.

Additionally, the reimbursement will be performed only if the following conditions are met:

1. Participants submit their individual participant report as requested by the European Commission through the Mobility Tool;

2. Participants and their sending organizations send the organizers a prove of dissemination activities.

#### Insurance:

The participants must possess a travel insurance covering them for the whole duration of the activity.

#### Program:

#### Participant's declaration:
